## SOUTHERN STATES ITEMS OF INTEREST.

Gleaned by the Picayune's Corps of Special Correspondents.

A Colored Politician Given a Sound Thrashing at Caronero

For Having Been Too Liberal in the Use of His Tongue.

The Populist Camp Meeting Promises to be an Immense Affair-Shoot. iug Affair in Concordia.

Lafayette, La., Aug. 13 .- It was currently reported this morning that Felismar Paddio, the well-known negro politician, had been lynched last night by the people in Carenero. As nothing definite could be ascertained here to the truth or falsity of the report, the Picayune man visited the town of Carenero for the purpose of getting full information of all happenings relative to the alleged occurreuce. The facts as gathered from most reliable sources are as follows: Yesterday evening Paddio and a number of followers entered the town of Carencro and, after visiting several places, went to the stole kept by Mr. Louis Delighie, where sat Justice of the Peace Frank Abbadie, read-ing a newspaper. Without any provocation whatever, the insolent negro began to heap a torrent of abuse on Judge Abbatile, cailing him a thief and applying other vile and derogatory epithets to the officer. Judge Abbadle was dumfounded and for several minutes could not collect his thoughts sufficiently to answer the impudent negro. He then very caimly ordered Paddio and his crowd to leave the town, and that immediately. This seemed to anger the negro and he renewed his attack upon the judge, saying: "You are a — thief; you stole my papers out of the post office. You can't say that you were drunk, for you have quit drinking!"

The negro and his company then went to another portion of the town and boasted of the tosults they bud heaped upon Judge Abbadle, who, in the meantime, had sworn out a warrant for Paddlo's arrest before Mayor D. A. Dimitry on the charge of assault and disturbance of the peace. Constable Alex Arceneaux arrested Paddlo und lodged him in the town tail.

This was about 5 o'clock. Mayor Dimitry fixed the ball at \$100 for the two charges. This ball was not forthcoming and Paddlo remained in jail. About by o'clock a large crowd collected around the jail and taking Paddlo thence administered to him a severe castigation. The negro was not killed, but the punishment he received must have rendered him almost helpless. most helpless.

The indignation aroused by the gross and altogether unprovoked assault upon Judge Abbadie, taken in connection with the previous insolent and overbearing conduct of the negro, was the prime cause and justification for the extreme measures adopted by the clizens of Carenero. As to l'addio's whereabouts or his present condition, nothing can be learned, but he was dismissed with the injunction to avoid Carenero in future.

The victim, Fellsmar Paddio, has for a long time played a conspicuous purt in the politics of this parish and has figured to some extent in state and national affairs. He has occupied subordinate positions in the New Orleans custom-house under Republican regime and was a delegate hast year to the St. Louis nominating convention. Several years ago, during the regulators' troubles, he left the mush and remained away for some time, but subsequently relumed.

The facts above were gleaned from personal interviews with the officials and citizens of Carenero. There appears to exist general satisfaction that the insolence of the negro had met with so severe and well merited resentment.
